Enhancements to Oral Health for Total Health



Oral Health for Total Health has expanded to help more members improve their oral and overall health. Since January 1, 2018, members who suffered a stroke or are diagnosed with Sjögren's syndrome — an autoimmune disorder that causes dry mouth and eyes — qualify for enrollment in Oral Health for Total Health. Oral Health for Total Health now offers enhanced dental benefits to members with these medical conditions:

- Diabetes.
- Coronary artery disease.
- Stroke.
- Oral cancer.
- Sjögren's syndrome.
- Pregnancy.

Members enrolled in the program don't pay anything for enhanced dental benefits when they see a participating provider. The services don't count toward their calendar year maximum and don't require a copayment.

CLINICAL FOCUS

Silver Diamine Fluoride

Since the beginning of this year, HMSA has covered an interim caries arresting medicament application (D1354). The medicament typically used under this code is silver diamine fluoride.

Silver diamine fluoride has been around for many years. Primarily used as a desensitizing agent, it's been recently used as a minimally invasive treatment for dental caries until definitive treatment can be performed.

Typically, silver diamine fluoride is used when a patient has a deep, active carious lesion and won't be able to return for conventional treatment (such as a restoration) for quite some time. This could apply to nursing home patients where travel to the office could be difficult, to students at school who may not have regular dental care, and children who are not yet able to tolerate more extensive dental procedures. Silver diamine fluoride won't be covered when the tooth it's applied to is being restored on the same date of service.

Although highly effective at arresting decay, silver diamine fluoride will stain the carious lesions it's applied to as well as any restorative margins it comes in contact with. Although this material is clear and odorless, it can stain skin and clothing, so anywhere that silver diamine fluoride is applied should be appropriately isolated. Patients should be aware of this before the fluoride is applied.

HMSA and our dentists are strong believers in preventive care. When used properly, silver diamine fluoride can help keep our members healthy.

BRUSHING UP

Costco – Wholesale

Costco Wholesale's dental plan has some unique benefits that may be different from our standard commercial plans. Specifically, Costco's dental plan doesn't pay for additional panoramic films (D0330) taken by an oral surgeon 12 months from the previous panoramic or full-mouth X-ray.

The full-mouth X-ray and panoramic film X-ray share the same frequency and are covered once every three years.
